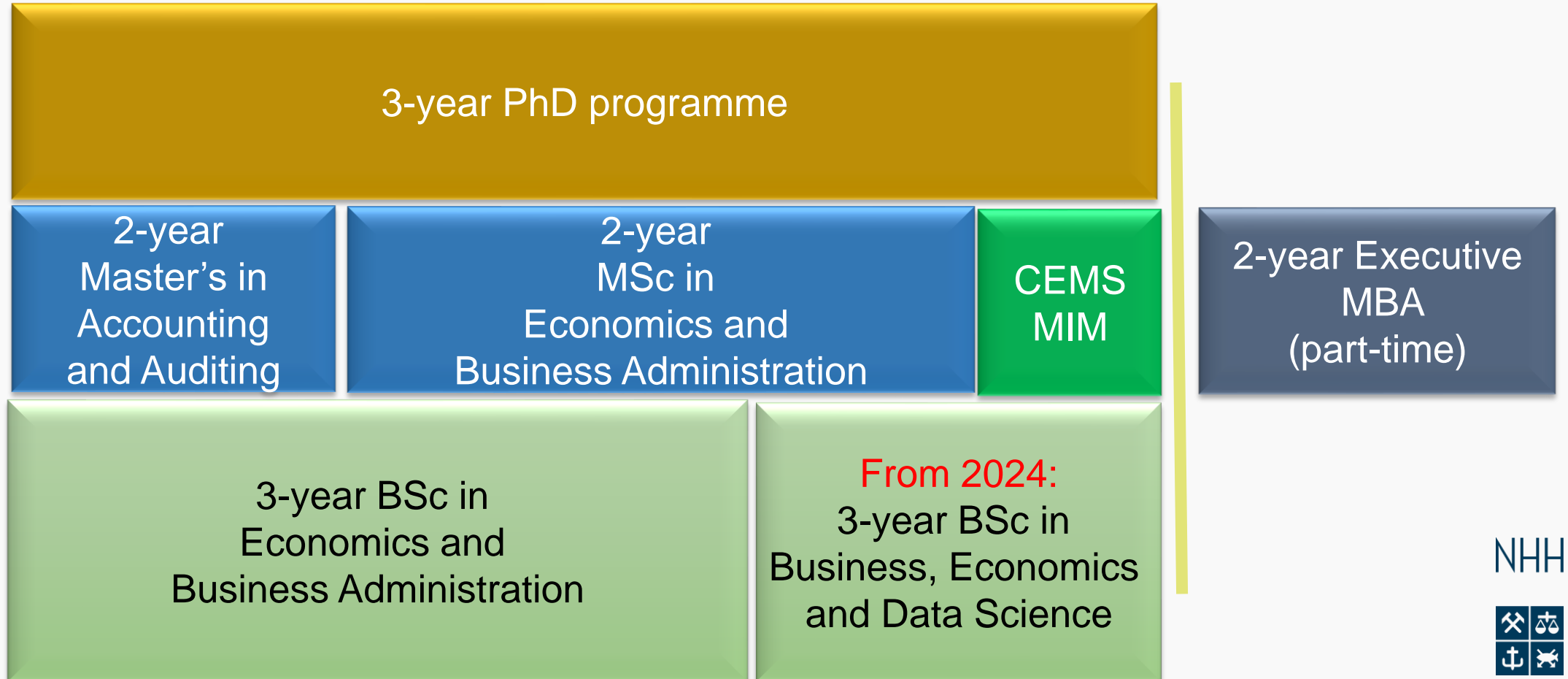

MSc in Economics and Business Administration

- Two-year programme that qualifies for jobs
 - ✓ as specialists, consultants and leaders
 - ✓ in the private and public sector
 - ✓ in Norway and internationally.
- Teaching mainly in English
 - ✓ and with a significant number of international students and international faculty.
- A wide variety of teaching and assessment methods
 - ✓ with an increasing focus on student-centred learning.
- Gives the title MSc in Economics and Business Administration
 - ✓ Master i Økonomi og Administrasjon (MØA).
- Is the final part of the 5-year “siviløkonom” programme
 - ✓ for those admitted based on a bachelor degree from NHH or a similar programme fulfilling specific requirements.
 - This would typically be a Norwegian Bachelor i Økonomi og Administrasjon (BØA) degree.

Job market survey 2023

- Employed
 - ✓ 92% six months after graduation; of these
 - 97% in relevant jobs
 - 93% with job offer before graduation.
 - ✓ 5% in further studies
- Average salary
 - ✓ NOK 588 000 (base) / 685 000 (total)

Programme structure

To ensure deep and broad knowledge and skills

- Major (hovedprofil)
 - ✓ Six courses (45 ECTS) from one of the majors.
 - ✓ A master thesis (30 ECTS) on a topic within your major.
- Electives
 - ✓ Six courses (45 ECTS).
 - ✓ At least three of these courses outside of your major.
 - ✓ Some of the electives can be combined as a minor (støtteprofil) on the diploma.
- Excellent international opportunities
 - ✓ Various international opportunities count as electives or a minor.
 - ✓ Approximately half of the students spend at least half a year abroad.

Programme course requirements

- **Mandatory core courses**
 - ✓ Specific requirements for each major.
 - ✓ Form the basis for more specialised courses in the major.
- **At least one course (7.5 ECTS) in empirical methods**
 - ✓ Ensures good methodological skills.
 - ✓ Gives a solid basis for your master thesis work.
 - ✓ Must be chosen within your major
 - See description of individual majors for available courses.
- **At least one course (7.5 ECTS) in Ethics, Responsibility and Sustainability (ERS)**
 - ✓ Can be taken as part of the major or as one of the electives.
 - ✓ Gives a solid foundation in ethics, responsibility and sustainability.
 - ✓ An overview of approved ERS courses will be available on the web site.

Another important requirement – the master thesis

- ✓ The master thesis is an excellent opportunity to demonstrate how you can apply your knowledge and skills to specific topics and research questions related to your major.
- ✓ It provides training in thinking and working independently under supervision.
- ✓ It counts for 30 ECTS and should typically be written in your final semester.
- ✓ Two students normally write together, and the topic/research question should reflect the majors of both students.
- ✓ You will get ample information about the master thesis during your master studies.
