# **Research Statement**

My main research interest is to analyse the drivers of economic inequality and the persistence of inequality. Using modern statistical tools and "big" administrative data, the focus is to identify causal drivers of inequality related to public and parental investments in children, complementarities in economic shocks across childhood, and how these factors are played out in inequality as adults in education, health and income. A particular focus is the persistence of inequality across generations.
